TERMS AND CONDITIONS OF ENTRY

Entry:

1. Entry to this competition is **FREE** and available to residents, businesses and communities within Drumheller Town limits, with the exception of the People's Choice Award for Best Residential Lights, which is judged by popular vote online and is open to residential properties within the distribution area of the Drumheller Mail.
2. To register your residential, commercial or community entry you must complete, sign and return the entry form to Town Hall, or register online at www.drumhellermail.com, by 12 noon on **Friday 7th December 2018**.
3. You can enter as many categories as you wish on the condition that your entry meets the criteria for the categories nominated.
4. Public viewing is an important part of the competition to allow as many people as possible to enjoy the displays.

Judging:

5. Displays may be a combination of Christmas lights and decorations.
6. Judging of 1st, 2nd & 3rd place for Best Residential Lights & Brightest Christmas Community will take place week commencing 10 December 2018, subject to weather.
7. To ensure that your property is judged **ALL** entrants should ensure that their displays are illuminated from 4.45pm on 7 December 2018 until the winners are announced.
8. There will be no opportunity for judges to re-visit any entrant that is unable to display during the specified judging period. Failure to have your display lit up will be reflected in scores.
9. Judging will be based on quality of display, design, creativity, originality and overall impression of display.
10. Judging of a residence will only apply to exterior displays and will be assessed from the front of the property.
11. The judges' decision is final and no correspondence will be entered into.
12. The People's Choice Award for Best Residential Lights and Best Commercial Christmas Display will be judged by online public ballot. The property/commercial display with the most votes will win.

Winners:

13. Prizes will be announced on Real Country 910, in the Drumheller Mail, on the Town of Drumheller website and Town and FCSS social media.
14. Winners of all categories will be announced on the Town of Drumheller website and social media by Friday 14 December 2018.
15. Prizes will be awarded to the property owner as named on the entry form.
16. Prizes are non transferable and will not be redeemable for cash.
17. The judge(s) reserve(s) the right to withhold the prize if there are insufficient entries in the category.
18. 2nd Prize for Best Residential Lights winner should note that the prize is \$50 towards the cost of dinner. Reservation must be made in advance.
19. Canalta People's Choice Award for Best Residential Lights winners should note that the prize is for 2 nights in a Standard Room at the Canalta Lodge in Banff. The prize should be redeemed before 20 December 2019 and cannot be used between 21 December 2018 – 1 January 2019. Reservation must be made in advance. There is a 24 hours cancellation policy.

Safety etc:

21. All entries must be visible from the exterior of the property without impeding pedestrian traffic in anyway.
22. Entrants are not to use the footpath, electricity poles, or any property outside their boundary for any purpose of their display unless they obtain written permission from the relevant authorities. Tenants should consult their landlords before considering their display.
23. The security of all of the displays remains the sole responsibility of the entrant.
24. The organizers and sponsors accept no responsibility for damage, injury or theft, which may occur as a result of your entry into this competition.
25. Ultimately you, as the entrant, are responsible for your display. The Town of Drumheller accepts no responsibility or liability for any actions or incidents relating to, or occurring during, the 'Light up the Night' Contest at or near the property of any entrant. Please ensure that you have adequate Property and Public Liability Insurance that protects you in relation to anything you propose doing as part of installing a lighting display upon your property, or that of the property owner, as well as your participation in the contest.
